E-mail Privacy

Your email address will only be used within the Golden Belt Community Foundation. The Golden Belt Community Foundation does not sell or rent email addresses to anyone outside the organization. Use of IP Addresses and Cookies

A unique number called an IP address identifies every computer on the Internet. Each time you connect to the Internet your machine is assigned an IP address. An IP address is a number that identifies each sender or receiver of information that is sent in packets across the Internet. The Foundation uses your IP address to help diagnose problems and to administer the Foundation website.

"Cookies" are small pieces of information that are stored by your browser on your computer's hard drive. Most web browsers automatically accept cookies, but if you prefer, you can edit your browser options to block them in the future. The Foundation does *not* use cookies to maintain information or history for any reason.

Registration Forms

The Golden Belt Community Foundation website registration forms require users to give us contact information (such as name and e-mail address), method of payment, and demographic information. The Foundation may use registrant contact information from the registration forms to send the user information about the Golden Belt Community Foundation. The registrant's contact information also is used to contact the visitor when necessary. Information regarding method of payment is collected for enrollment, registration and to process gifts or grants.

E-Commerce for Donations/Receiving Publications and News

The website www.goldenbeltcf.org uses an order form for persons to request information or make donations. The Foundation collects visitor's contact information (such as e-mail address) and method of payment. Contact information from the order form is used to process orders and to send information about the Foundation or program. User payment information that is collected is used to check the users' identity and bill the user for products and services. This information is transmitted via a secure email.
